# The National Hispanic Leadership Agenda

The National Hispanic Leadership Agenda (NHLA) calls for a spirit of unity among Latinos nationwide to provide the Hispanic community with greater visibility and a clearer, stronger voice in our country's affairs. The NHLA seeks a consensus among Hispanic leaders to help frame policy and promote public awareness of the major issues that affect Latinos at a national level. The NHLA was founded in 1991 as a non-partisan coalition of major Hispanic national organizations and distinguished Hispanic leaders from across the nation. It represents all major ethnic groups in the Latino community – Mexican Americans, Puerto Ricans, Cuban Americans, and other Americans whose countries of origin are in the Caribbean or in Central or South America. Governing the NHLA is a 35-member board comprised of the chief officers of 27 national Hispanic organizations, along with elected officials, corporate executives, and other prominent professionals. The goals that guide its efforts are: (1) to identify, analyze and shape public policies on Latino issues, based upon a consensus of Latino leaders nationally; (2) to prepare and disseminate a consensus-based policy agenda that specifies the nature and scope of Latino concerns and needs throughout the country; and (3) to promote greater awareness of and attention to Latino concerns among the nation's policy-makers and civic community leaders, as well as among the general public.

# Methodology

In the Spring of 1999, the Board of Directors of the National Hispanic Leadership Agenda (NHLA) authorized the publication of its 1999 Hispanic Legislative Scorecard covering the 1st session of the 106th Congress, soon after it adjourned. A Scorecard Committee was appointed to identify and recommend to the Board votes for inclusion in the document (see front cover for a listing of Committee members).

The fundamental purpose of the Scorecard is to ensure that Latino leaders, organizations, and voters are fully informed about the performance of federal legislators on issues of importance to the Hispanic community. In addition, we seek to ensure that U.S. Representatives and U.S. Senators are fully aware that their key votes on issues of particular significance to Hispanic Americans will be scrutinized and published.

Pursuant to discussions of the NHLA Board, the Committee used three basic criteria to select key votes:

- **Importance** of the vote to the Hispanic community, measured both substantively and symbolically,
- **Prior notice** to members of Congress regarding the position of NHLA member organizations, as evidenced by a formal communication by at least one NHLA member organization to the Congress,
- **Substantial consensus**, although not necessarily unanimity, among NHLA member organizations regarding the “pro-NHLA” position.

During the Committee’s deliberations, an informal “issue diversity” criterion also emerged. In other words, the Committee sought some degree of balance in the votes selected so that the Scorecard would not be unduly weighted toward any single issue, e.g., immigration or education. Committee decisions were arrived at by consensus. Member organizations identified potential votes, which were then discussed, sometimes at length. Only those votes reflecting a consensus of the Committee were recommended to the Board for inclusion.

On January 26, 2000, after consideration and some revisions of the Committee’s recommendations, the Executive Committee of the NHLA Board of Directors selected the votes included herein for inclusion in the Scorecard.

# KEY VOTES

**OVERVIEW:** In the section below, each key House and Senate vote is characterized by a vote number, the lead sponsor, a brief description, and identification of the “pro-NHLA” position. There are significantly more House votes than Senate votes, a reflection of the fact that a greater volume of key votes took place in the House than in the Senate.

## KEY VOTES IN THE HOUSE OF REPRESENTATIVES

### EDUCATION

1. **Bill to Provide More Flexibility in Federal Education Programs.** H.R. 800 – Education Flexibility Partnership Act of 1999 (“Ed Flex”). Castle (R-DE) bill allows states to waive requirements under certain federal education programs. Many of these requirements were included in laws, such as Title I of the Elementary and Secondary Education Act and the Emergency Immigrant Education Program, to improve educational outcomes for disadvantaged children and hold states accountable for using federal funds for this purpose. Critics charge that H.R. 800 allows states to ignore requirements intended to hold schools accountable for helping these students, including those with limited-English proficiency, meet rigorous academic standards. Billed passed 330-90 (RC# 41), March 11, 1999. (PRO-NHLA POSITION: No)
2. **Bill to Address Professional Development for Teachers.** H.R. 1995 – Teacher Empowerment Act. McKeon (R-CA) bill would combine teacher professional development programs in the Elementary and Secondary Education Act and Goals 2000: Educate America Act. NHLA members argued that this legislation would not target professional development funds for school districts with the largest numbers or percentages of uncertified or inexperienced teachers. In addition, the bill would provide no direct funding to address the critical shortage of qualified bilingual education teachers, according to NHLA members. Bill passed 239-185 (RC# 320), July 20, 1999. (PRO-NHLA POSITION: No)
3. **Bill to Renew Compensatory and Bilingual Education Programs.** H.R. 2 – Students Results Act of 1999. Goodling (R-PA) bill reauthorizes Title I compensatory education and strengthens accountability provisions. The bill also would prohibit schools from providing compensatory education services to limited-English-proficient students until they receive consent from the parents of these children. In addition, the bill would restrict provision of services under the Bilingual Education Act solely to English language acquisition, ignoring other academic areas, such as math, science, and social studies, according to NHLA members. Bill passed 358-67 (RC# 526), October 21, 1999. (PRO-NHLA POSITION: No)
4. **Bill to Block Grant Federal Education Funding.** H.R. 2300 – Academic Achievement for All Act (“Straight A’s Act”). Goodling (R-PA) bill would block grant most federal education dollars to states. This legislation would eliminate targeting of education programs in exchange for performance agreements between states and the U.S. Department of Education that would include academic benchmarks for students. However, critics charge that these agreements would not be monitored or reviewed by the U.S. Department of Education during the period in which the performance agreement is in effect, which would jeopardize the education of disadvantaged students for whom compensatory programs were intended. Billed passed 213-208 (RC# 532), October 21, 1999. (PRO-NHLA POSITION: No)

---

## FEDERAL BUDGET

5. **Bill to Reduce Discretionary Spending.** H. Con. Res. 68 – Conference Report for concurrent FY 2000 Budget Resolution. Kasich (R-OH) resolution setting federal spending targets requiring large cuts in domestic discretionary programs. According to NHLA members, the Resolution largely cuts programs under Labor/HHS and HUD appropriations bills, including human needs programs that benefit the Hispanic community. Conference Report passed 220 – 208 (RC# 85), April 14, 1999. (PRO-NHLA POSITION: No)
6. **Bill to Reduce Funding for Housing Assistance.** H.R. 2684 – House version of FY 2000 Appropriations bill for Housing and Urban Development. Walsh (R-NY) bill reduces funding levels for housing assistance programs that, according to NHLA members, largely serve the low-income population. Bill passed 235 – 187 (RC# 403), September 9, 1999. (PRO-NHLA POSITION: No)
7. **Bill to Reduce Funding for Labor Department and Health and Human Services Programs.** H.R. 3064 – Rolled into Conference Report for District of Columbia FY 2000 Appropriations. Istook (R-OK) FY 2000 Appropriations bill for Labor-HHS would, according to NHLA members, require massive cuts in important education, job training, health and other programs. Conference Report passed 218 – 211 (RC# 549), October 28, 1999. (PRO-NHLA POSITION: No)

## INCOME SECURITY & FAMILY SUPPORT

8. **Amendment to Strike Funding Rescissions used as Offsets for Providing Disaster Relief to Central America and Caribbean.** H. Amdt. 35 to H.R. 1141. Obey (D-WI) amendment would have struck “offsets” – cuts in domestic spending – that were applied only to the Central America relief provisions of the bill (and not to the agricultural and Kosovo provisions). NHLA members argued that singling out the Central American provisions was discriminatory and that the cuts would be harmful to low-income households. Amendment rejected 201 - 228 (RC# 68), March 24, 1999. (PRO-NHLA POSITION: Yes)
9. **Bill to Reduce Federal Taxes - Conference Report for H.R.2488.** Archer (R-TX) bill to amend the Internal Revenue Code of 1986 to reduce individual income tax rates, to provide marriage penalty relief, to reduce taxes on savings and investments, to provide estate and gift tax relief, to provide incentives for education savings and health care, and for other purposes. According to NHLA members, the bill would have provided major tax reductions for the wealthy and virtually nothing for working class and low-income families. Conference Report passed 221-206 (RC# 379), August 5, 1999. (PRO-NHLA POSITION: No)

## CIVIL RIGHTS

10. **Local Census Quality Check Act.** H.R.472, Miller (R-FL) bill to require the Census Bureau to implement a post-census local review as part of each decennial census. According to NHLA members the Bill would have done nothing to address – and may have exacerbated – the undercount of Latinos. Bill passed 223 - 206 (RC# 89), April 14, 1999. (PRO-NHLA POSITION: No)
11. **Amendment to Prohibit Campaign Contributions from Individuals Who Are Not Citizens or Nationals of the United States.** H. Amdt. 453 to H.R.417, Campaign Finance Reform bill. Bereuter (R-NE) amendment would prevent legal permanent residents from contributing to political campaigns. According to NHLA members, the amendment would have a negative and disproportionate impact on Latinos and could “chill” legitimate contributions from U.S. citizens. Amendment agreed to 242 - 181 (RC# 414), September 14, 1999. (PRO-NHLA POSITION: No)

## KEY VOTES IN THE SENATE

### EDUCATION

1. **Motion to Prevent Preservation of Accountability in use of Title I Funds.** Motion to table S. Amdt. 32, Wellstone (D-MN) to S. 280, which was eventually substituted by S. 271, the Education Flexibility Partnership Act of 1999. S. 271 allows states to waive requirements under certain federal education programs. Many of these requirements were included in laws, such as Title I of the Elementary and Secondary Education Act and the Emergency Immigrant Education Program, to improve educational outcomes for disadvantaged children and hold states accountable for using federal funds for this purpose. According to NHLA members, S. 271 allows states to ignore requirements intended to hold schools accountable for helping these students, including those with limited-English proficiency, meet rigorous academic standards. Wellstone amendment would have maintained accountability for use of Title I funds for low-income children. Motion to table passed 55-42 (RC# 30), March 1, 1999. (PRO-NHLA POSITION: No)

### FEDERAL BUDGET

2. **Bill to Reduce Discretionary Spending.** H. Con. Res. 68 – Conference Report for concurrent FY 2000 Budget Resolution, sets federal spending targets requiring large cuts in domestic discretionary programs. According to NHLA members, the Resolution largely cuts programs under Labor/HHS and HUD appropriations bills, including human needs programs that benefit the Hispanic community. Conference Report passed 54-44 (RC# 86), April 15, 1999. (PRO-NHLA POSITION: No)
3. **Bill to Reduce Funding for Labor Department and Health and Human Services Programs.** H.R. 3064 – Rolled into Conference Report for District of Columbia FY 2000 Appropriations, FY 2000 Appropriations bill for Labor-HHS would, according to NHLA members, require massive cuts in important education, job training, health and other programs. Conference Report passed, 49-48 (RC# 343), November 2, 1999. (PRO-NHLA POSITION: No)

### INCOME SECURITY & FAMILY SUPPORT

4. **Bill to Reduce Federal Taxes** - Conference Report for H.R.2488 to amend the Internal Revenue Code of 1986 to reduce individual income tax rates, to provide marriage penalty relief, to reduce taxes on savings and investments, to provide estate and gift tax relief, to provide incentives for education savings and health care, and for other purposes. According to NHLA members the bill would have provided major tax reductions for the wealthy and virtually nothing for working class and low-income families. Conference Report passed 50-49 (RC# 261), August 5, 1999. (PRO-NHLA POSITION: No)
5. **Motion to Prevent Increase in the Federal Minimum Wage** – Motion to table S. Amdt. 2751 to S.625, Kennedy (D-MA), amendment to Bankruptcy Reform Act of 1999 to increase the federal minimum wage to \$6.15 by January 1, 2001. Motion would prevent further debate and a vote on the amendment, which NHLA members argued would benefit a large number of Latino “working poor” families. Motion passed 50-48, (RC# 356), November 9, 1999. (PRO-NHLA POSITION: No).

---

## CIVIL RIGHTS

6. **Motion to Table Amendment to Preserve Community Reinvestment Act Protections in the Financial Services Modernization Act of 1999.** S. Amdt. 302 in the nature of a substitute bill offered by Daschle (D-SD) for Sarbanes (D-MD) to S.900, Senate version of Gramm (R-TX) bill. S. 900 permits the mixing of banking and commerce, making it easier for banks, brokers and insurance companies to merge services, without simultaneously modernizing and expanding the Community Reinvestment Act (CRA). The bill exempts small banks from CRA requirements, which according to NHLA members, makes it more difficult for community groups to comment on merger applications by including “safe harbor” provisions for some banks, and includes a “sunshine” provision requiring community organizations that have CRA agreements to undergo burdensome reporting requirements. The substitute amendment would have deleted these CRA provisions. Motion to table amendment passed, 54-43 (RC#100), May 5, 1999. (PRO-NHLA POSITION: No.)
7. **Motion to consider the nomination of Richard A. Paez.** Procedural motion offered by Daschle (D-ND) to proceed to executive session to consider the President’s nomination of Judge Paez to be United States Circuit Judge for the Ninth Circuit Court of Appeals. If confirmed, Paez would be one of the few Latinos on the federal appellate courts, according to NHLA members. Motion was rejected 45-53 (RC# 283), September 11, 1999. (PRO-NHLA POSITION: Yes)
