## RESOLUTION FOR INVESTIGATING ELECTION FRAUD FACILITATED BY ELECTRONIC VOTING SYSTEMS, AND ACCUSATIONS OF VOTER FRAUD AGAINST UNDOCUMENTED LATINOS

WHEREAS, LULAC is our Nation's oldest, largest, and most respected Hispano/Latino civil rights organization, established in 1929. Our mission is to seek the advancement of Hispanic Americans in the areas of education, employment, and civil rights; and

**WHEREAS,** LULAC members have worked tirelessly to ensure that collectively we participate fully in our American democracy resulting in Latinos becoming more visible as candidates on the world stage and our voices being heard at the highest levels of government, and

WHEREAS, our successes risk being marred by recent accusations of wide-spread Voter Fraud made against undocumented individuals of Hispanic/Latino descent, which is a false narrative that reflects badly on the Hispanic/Latino descent, which is a false narrative that reflects badly on the Hispanic/Latino population at large, and also distracts the public from a more probable disruptor of election results, Election Fraud through both internal and external attacks or hacking Election Voting Systems, and

**WHEREAS**, this false narrative makes little sense given the pervasive fear undocumented residents have of interacting with County officials including to register or to vote, but may provide a convenient scapegoat for bad-actors who may exploit the names for various purposes, and

**WHEREAS**, we are concerned that Election Fraud corruption is protected at all levels by internal and external forces which include elections administrators that deny it exists and lack the tools to fully investigate the election voting systems procured by others for their use, law enforcement and elections officials that refuse to enforce Election Laws, the election software/hardware industries that profit from the status quo of providing a substandard, hackable product, by the very media that distract the public from the truth – that electronic voting results require a paper backup to be trustable, and finally, by the undetectable hacker(s) that has changed election results.

**BE IT RESOLVED** that LULAC actively demands the Secretary of the Department of Homeland Security and the President of the United States to designate Venezuela under subsection (b)(1)(C) of section 244 of the Immigration and Nationality Act (8 U.S.C. 1254a) for a period of 18 months to permit nationals of Venezuela to be eligible for temporary protected status in accordance with such section

**THEREFORE BE IT RESOLVED** that we insist on the following to ensure Election Integrity:

- 1. A thorough and independent examination of electronic voting systems
- 2. An auditable paper trail backup system which also enables the Public to authenticate all essential election processes without need for special expertise.

3. That poll watchers and registered observers be given access to all official registration documentation and sign-in sheets, and enhanced ability to audit elections procedures, permission to photograph and record video at the Central Count, and that they be included in any and all elections processing

**FURTHERMORE, BE IT RESOLVED** that we will fight all media stories that scare Latinos from voting, and insist that Election Fraud facilitated by electronic voting machines and the industries/people that profit from them be investigated.
