Dear Member of Congress:

As leaders representing national Latino organizations engaged in voter education and registration efforts across the country—the Hispanic Federation, the Labor Council for Latin American Advancement (LCLAA), the League of United Latin American Citizens (LULAC), Mi Familia Vota Education Fund, the National Council of La Raza (NCLR), and Voto Latino—we write to inform you of our intent to release a *National Latino Immigration Report Card for 2014*.

Attached you will find a document indicating your current grade based on actions to date. However, you have until the end of June to improve your grade by taking steps to advance immigration reform. Our organizations will review selected congressional actions, including votes on legislation and amendments on the issue of immigration, co-sponsorship of key immigration-related bills that include a path to citizenship, and public statements that clearly declare support for immigration reform with a path to citizenship and urge House Republican leadership to bring a bill to the floor. These actions will determine your report card grade, which can range from an A (Excellent) to F (Unacceptable).

Our organizations will determine your grade based on actions you take to advance immigration reform and the following:

- Co-Sponsorship of H.R. 15, Border Security, Economic Opportunity, and Immigration Modernization Act ([List of co-sponsors](#))
- Signature on Discharge Petition for H.R. 15, Border Security, Economic Opportunity, and Immigration Modernization Act ([Current signatures on 113th Congress Discharge Petition Number 0009](#))
- A recorded “NO” vote on Rep. Steve King’s Amendment to H.R. 2217, Department of Homeland Security Appropriations Bill ([Roll Call Number 208 in 113th Congress](#))
- A recorded “NO” vote on the “ENFORCE Act of 2014” H.R. 4138 ([Roll Call Number 124](#))

- A recorded “NO” vote on the Faithful Execution of the Law Act of 2014, H.R. 3973 ([Roll Call Number 129](#))
- A recorded “YES” vote on the Nadler amendment A No. 2 to the “ENFORCE Act” ([Roll Call Number 121](#))
- A recorded “YES” vote on the Deutch amendment to H.R. 2217 ([Roll Call Number 198](#))

Our organizations will also review public statements you have made in support of immigration reform with a road to earned citizenship in the House of Representatives and public statements urging the House Republican leadership to act now. This additional review will show your support and sense of urgency for the passage of immigration reform.

Our organizations intend to release the *National Latino Immigration Report Card for 2014* by July 2014, leaving you the month of June 2014 to improve your grade. Following the release of the *National Latino Immigration Report Card for 2014*, a coordinated effort will be launched to bring attention to your record on the important issue of immigration prior to key midterm elections.

We urge you to take action in support of immigration reform prior to the release of our *National Latino Immigration Report Card for 2014*.
