Amendment No. 1

Proposed new National President's Term Limits; an Amendment to the LULAC National Constitution 2017

The following amendment to the LULAC National Constitution (Page 29) will be submitted in accordance to Article XIV, Section 2 for consideration and vote at the 2017 LULAC National Convention to be held July 4-8, 2017 in San Antonio, Texas.

Article VIII – National Officers, Section 1, Elective Officers; Currently states “The following positions will be filled by majority vote of the General Assembly each year.” Insert addition to read “The following positions will be filled by majority vote of the General Assembly each year, **as herein specified.**”

(a) National President

Insert after National President.

National President **will be elected every two years, with a four year term limit. This limitation is applicable to the National Presidents term only.**
